


## Urgent Matter


From November 28, 2011, Kenneth White (aka Popehat) via email harassed an individual by the name of Marc Stephens. Kenneth also tried to locate this individual by using an unidentified person on Twitter, as seen below. After harassing Stephens, ironically Mr. White published an article claiming he was threatened by Stephens. Mr. White does not know the entire story between the cancer clinic and Rhys Morgan. Yet he harassed Stephens. See below.

**CODE OF ETHICS.** It is inappropriate for a California attorney to conduct himself in this manner. Also, what Mr. White does not realize is that the Santa Monica, California address he has investigated, and currently posted online, is owned by a United States Honorable Judge. Posting this information online could potentially increase the danger of physical violence.

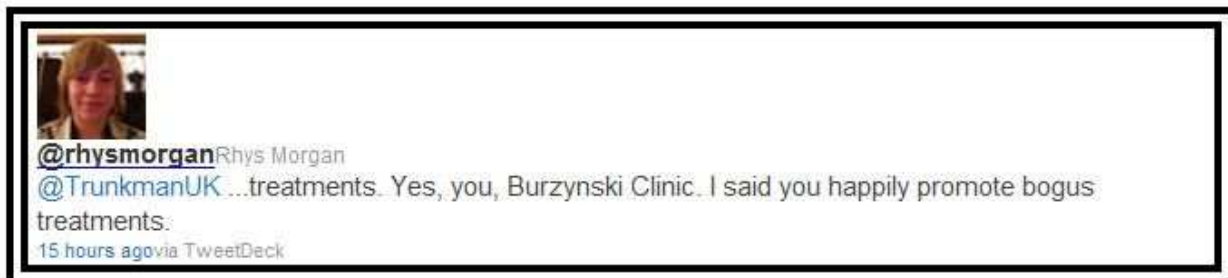

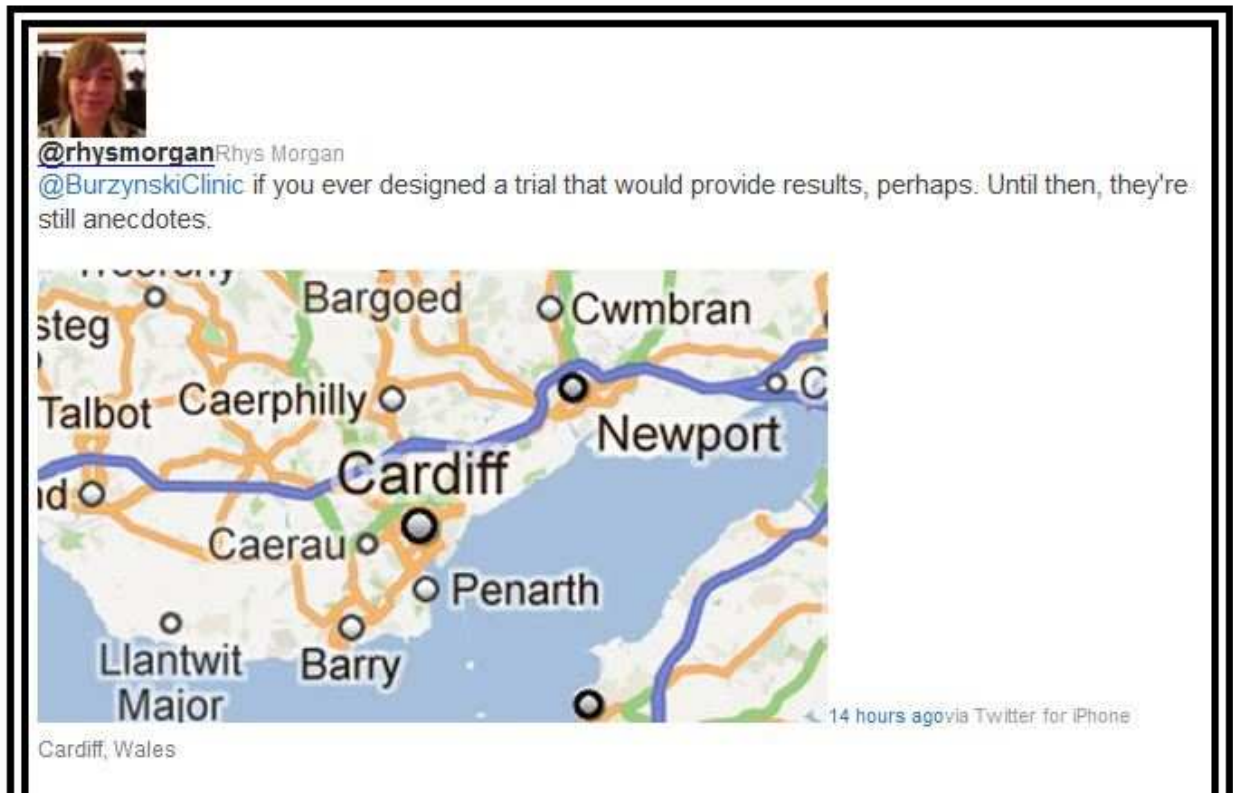

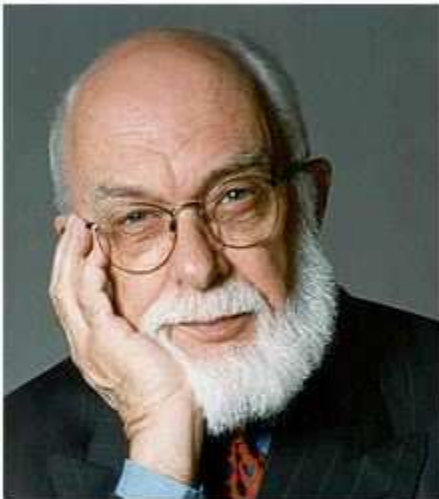
