20 The petition of St. Lucia Free Press for an order to quash the invalid foreign subpoena,
21 enjoin further subpoenas, and award reasonable expenses under California Civil Code § 1987.2
22 came on regularly for hearing by the court on February 13, 2014. Petitioner appeared by counsel
23 Catherine R. Gellis; Respondent appeared by counsel David Owens. On proof made to the
24 satisfaction of the court that the petition should be granted,

25 IT IS HEREBY ORDERED that the motion to quash the subpoena directed to
26 Automattic, Inc. is granted.

27 .IT IS HEREBY FURTHER ORDERED that Respondent Oliver Gobat shall not issue or
28 cause to be issued any further subpoenas to Automattic, Inc., seeking the identity or identifying

1 information regarding the poster of the allegedly defamatory speech that is the subject of this

3 IT IS ALSO HEREBY FURTHER ORDERED that Respondent Oliver Gobat or his
4 attorney David Owens, being jointly and severally liable, pay to Petitioner via Petitioner's
5 counsel Catherine R. Gellis the reasonable expenses incurred in bringing this petition, including
6 \$15,000 ~~in reasonable attorney fees and \$10,000 in additional costs~~
7 ~~and expenses~~ payable in 30 days.
